### Issue:

Sardar wala is a village of union council Jhok wains bosan Town Multan having about 150-200 households. The people of different sect lived in this area but Ahl-e-Sunnat and Deoband community had influence in the village because these sects are in majority. They did not allow the Ahl-e-Tashi community to convene Majlis in this area as well as did not allow introducing themselves according to their sect. All the people belong to Ahl-e-Tashi sect used to go to Multan or to Sahi Chawan to attend the Majlis. This was creating the issue (financial and Mobility) to move daily for Majlis. There was no plate form to resolve this issue.

### How to Issue Resolved:

Manzoor Hussain said "Sanjh Pakistan started its project Wasaib Aman Kaths (WAK) in July 2018 and conducted theater with the message of peace, tolerance and especially on interfaith harmony. The community members participated in this theater. When Sanjh Pakistan formed Wasaib Amna Kath (WAK) in our village, I become a part of this WAK. I am from Ahl-e-Tashi so the other members were not treated well with me due to my sect. I feel myself as unnecessary part of the WAK but When Sanjh Pakistan team arranged the CVE training in our village then I feel confidence in me to raise my issue. The other WAK members felt ashamed for their bad behavior in start and they started to promote interfaith harmony in the community through different Peace activities. With the continuous efforts of all WAK members, now I can say that there is very positive change in the behaviors of the community members which had influence in our village. Those community members started respect of other sect and said "We all are equal and having equal rights to live with our own choice sect or faith. Furthermore, he said "If we will give the equal rights to others because peace among the different sect is precondition for society peace. If we understand the said thing then we will be able to live united with peace and promote interfaith harmony". Sanjh Pakistan is working in our area from last year. I am Happy to share with you that in the Last Moharam-ul-Haram, The community members of Ahl-e-Sunnat and Deoband sect come at my home and said "Everyone has a right to offer their prayer (Ibadat) according to his sect or faith. We did not have the right to stop you to obey your

sect. So, from now you can conduct Majlis at your home. *Very first time, I conducted Majlis at my home and the Ahl-e-Sunnat and Deoband community members participated in the majlis as well as they conducted Melad in Rabi-ul-Awal and invited me in this melad.
